

Trading on margin can be risky, especially in fast moving markets. Rakuten Securities Hong Kong Limited (“Rakuten Securities HK”) has implemented margin procedures which are designed to protect clients and Rakuten Securities HK as well as to comply with relevant SFC regulations. Please take a few minutes to read through these procedures and don't hesitate to contact us if you have any questions.

保證金外匯交易存在風險，尤其在市場波動的時候。樂天證券香港有限公司（「樂天證券香港」）所實施的補倉程序，其目的是為了保障客戶及本公司，和符合證監會的相關監管要求。客戶若對以下政策和程序有任可不明白的地方，歡迎隨時與我們聯絡。

Trading FX on margin with Rakuten Securities HK requires that each trading account has sufficient balance to cover open positions at all times. Generally speaking, the minimum Initial Margin (amount required to open a new position) requirement is 5% of gross principal value of the contract*, the minimum Maintenance Margin (amount required to maintain an open position) requirement is 3% of gross principal value of the contract* and the minimum Liquidation Margin (amount below which all open positions will be liquidated) is 2% of gross principal value of the contract*. However, the margin requirements could vary with the specific currency pairs, account size and may change from time to time at the sole discretion of Rakuten Securities HK.

在樂天證券香港做保證金外匯交易，任何時候交易賬戶都需要有足夠的資金以維持所有持倉。一般而言，初始保證金最低要求(建立倉位的所需資金)是合約總資金價值的 5% *，維持保證金最低要求(維持倉位的所需資金)是合約總資金價值的 3% *，而自動結算保證金最低要求(當資金低於這要求時，所有倉位會立即被平倉)則是合約總資金價值的 2% *。不過，保證金要求可能會隨特定貨幣對和賬戶規模而有所不同，及可能會在樂天證券香港的自行決定下隨時改變。

Rakuten FX accounts 樂天 FX 賬戶

1. Initial Margin Warning 初始保證金提示

If the equity in an account fails to meet the Initial Margin requirement, Rakuten Securities HK will issue an Initial Margin Warning; a message will be posted under “Message” on the trading platforms and a notification email will be sent to client’s registered email address. No new open position will be allowed on the account until the equity is recovered to or over Initial Margin requirement level.

若賬戶淨值未能達到初始保證金要求，樂天證券香港會發出初始保證金提示。提示信息將發佈於交易平台「信息」窗口上，同時向客戶的登記電郵地址發送提示郵件。在賬戶淨值恢復初始保證金水平或以上前，該賬戶內均不能建立任何新倉位。

2. Margin Call 補倉指令

If the equity in an account fails to meet the Maintenance Margin requirement by 4:55 am HKT Tuesday to Saturday (EST Summer Hours) / 5:55 am HKT Tuesday to Saturday (EST Winter Hours), Rakuten Securities HK will issue a Margin Call, a message will be posted under “Message” on the trading platforms. A Margin Call Alert email will be sent out to client’s registered email address with details and a deadline for settlement.

若賬戶淨值於香港時間星期二至六凌晨五時正(美東夏令時間) / 香港時間星期二至六凌晨六時正(美東冬令時間)未能達到維持保證金要求，樂天證券香港會發出補倉指令，提示信息將發佈於交易平台「信息」窗口上。同時，追加保證金通知電郵將發送至客戶的登記電郵地址，當中會詳細解釋相關的補倉事宜和限期。

3. Liquidation 強制平倉

All open positions will be liquidated if and when the following events occur:

在以下情況，所有未平倉合約會給強制平倉：

3.1 Where the equity in an account drops to or below Liquidation Margin level, all open positions are closed immediately regardless of any previous email, phone or system messages relating to margin warnings. At this time a message will be posted to “Messages” on the trading platforms and a notification email will be sent out to client’s registered email address.

當賬戶淨值跌至或低於強制平倉水平，不論曾否收到由電郵、電話或交易系統所發出的任何追加保證金提示，交易系統均會立即把所有未平倉合約全部平倉，而不會作任何事前通知或警告。與此同時，提示信息將發佈於交易平台「信息」窗口上，同時向客戶的登記電郵地址發送提示郵件。

3.2 Where an account has not been sufficiently funded to or over Maintenance Margin level by the deadline set in a Margin Call Alert email. All open positions will be closed at 8 am HKT onwards (Monday to Friday).

若交易賬戶未能在追加保證金通知電郵的最後限期前達到或高於維持保證金要求水平，所有未平倉合約會在香港時間星期一至五上午八時後被平倉。

TS 賬戶

1. Margin Call 補倉指令

If the equity in an account fails to meet the Maintenance Margin requirement, Rakuten Securities HK will issue a margin call warning, a “W” will show up on the “MC” column in the “Accounts window” of the platform and a “Pop-Up” message will appear in the “messages” window of the Trading Station.

若賬戶淨值未能達到維持保證金要求，樂天證券香港會發出補倉指令通知，在「賬號」窗口上，「補倉」一欄會顯示「W」，在福匯交易平台 II 上的「訊息」窗口亦會顯示補倉指令訊息。

1.1 No new open positions will be allowed on the account until the Margin Warning has been reset to “N” by Rakuten Securities HK.

在樂天證券香港把補倉指令撤銷或轉為「N」前，該賬戶內均不能建立任何新倉位。

1.2 If a Margin Warning persists by 5 am HKT Tuesday to Saturday (EST Summer Hours) / 6 am HKT Tuesday to Saturday (EST Winter Hours), Rakuten Securities HK will issue a Margin Warning email to the account holder with details and a deadline for settlement.

若補倉指令持續至香港時間星期二至六凌晨五時正 (美東夏令時間) / 香港時間星期二至六凌晨六時正 (美東冬令時間)，樂天證券香港就會向賬戶持有人發出追加保證金電郵，當中會詳細解釋相關的補倉事宜和限期。

1.3 The Margin Warning status will be reset by Rakuten Securities HK at 5 am HKT Tuesday to Saturday (EST Summer Hours) / 6 am HKT Tuesday to Saturday (EST Winter Hours) if the client's account equity meets the maintenance margin requirement (3%). The Margin Warning status can be reset upon request when the client has at least US\$300 for USD denominated account or HK\$2,400 for HKD denominated account in “Usbl Maint Mr” (usable maintenance margin) column. To request the margin warning be reset please call the Rakuten Securities HK dealing room at (852) 2119 0118 during our phone dealing services hours between 8 am HKT to 11:59 pm HKT from Monday to Friday.

在香港時間星期二至六凌晨五時正 (美東夏令時間) / 香港時間星期二至六凌晨六時正 (美東冬令時間)，若賬戶淨值達到維持保證金要求(3%)，樂天證券香港就會撤銷有關補倉指令。或當賬戶的「可用維持保證金」一欄超過 300 美元 (美元結算賬戶)或 2,400 港元(港元結算賬戶)，客戶可在電話交易服務時間星期一至星期五上午 8:00 至晚上 11:59 (香港時間)致電(852) 2119 0118 與樂天證券香港的交易室聯絡，要求撤銷補倉指令。

2. Liquidation 強制平倉

All open positions will be liquidated if and when the following events occur:

在以下情況，所有未平倉合約會給強制平倉：

1. Where the “Usable Margin” in a trading account drops to or below zero: all open positions are closed immediately regardless of any previous email, phone or system messages relating to margin warnings. At this time no notices or additional warnings will be provided by Rakuten Securities HK. The Liquidation Margin level may vary from time to time based on the margin requirements table for each currency pairs.

當「可用保證金」跌至或低於零時，不論曾否收到由電郵、電話或交易系統所發出的任何追加保證金通知，交易系統均會立即把所有未平倉合約全部平倉，而不會作任何事前通知或警告。根據保證金要求表，每個貨幣對的自動結算保證金水平可能會隨時改變。

2. Where an account has not been sufficiently funded to or over Maintenance Margin level within the deadline set in a Margin Warning email. All open positions will be closed at 8 am HKT onwards (Monday to Friday). At this time no notices or additional warnings will be provided by Rakuten Securities HK.

若交易賬戶未能在追加保證金通知電郵的最後限期前達到或高於維持保證金要求水平，所有未平倉合約會在香港時間星期一至五上午八時後被平倉，而不會作任何事前通知或警告。

有關存款的重要事項

Rakuten Securities HK seeks to process funds as quickly as possible as we understand our clients' needs with regards to a fast moving market. Please note however that Rakuten Securities HK does require at least one full business day to process funds. In order to make sure your funds are processed quickly, please review the funding policies at www.sec.rakuten.com.hk/en/accounts/deposit-funds/ and ensure that any additional documentation has been submitted with your funds.

樂天證券香港瞭解在波動的市況下，客戶希望資金能盡快處理。但請注意，樂天證券香港需要最少一個完整工作日處理資金。為確保閣下的資金能迅速處理，請瀏覽 www.sec.rakuten.com.hk/tc/accounts/deposit-funds/ 參考有關存款資料和政策，並請確保已遞交相關的匯款憑證。

If you are funding via international transfer please make note that extra time is needed by the banks to clear such payments (it may take 3-5 business days and is wholly out of the control of Rakuten Securities HK).

如閣下透過國際電匯存入資金，請注意銀行需要較長時間結算(一般 3 至 5 個工作日，而且結算時間是樂天證券香港不能控制的)。

ADDITIONAL NOTICES: 附加通知：

Forex Transactions carry a high degree of risk. The amount of Initial margin may be small relative to the value of the foreign currency so that transactions are 'leveraged' or 'geared'. A relatively small market movement may have a proportionately larger impact on the funds you have deposited or will have to deposit: this may work against you as well as for you. You may sustain losses in excess of your initial margin funds and any additional funds deposited with the firm to maintain your position. If the market moves against your position or margin levels are increased, you may be requested to pay substantial additional funds on short notice to maintain your position. If you fail to comply with a request for additional funds within the time prescribed, Rakuten Securities HK in its sole discretion may liquidate any or all of your positions at a loss. Be aware and fully understand you could sustain losses in excess of your deposit.
